Emergency Preparedness is Everyone's Responsibility: Part 1

The Finger Lakes Independence Center offers FREE Emergency Preparedness presentations to groups of older adults and people with disabilities. Presentations and all materials are funded through a grant from the United Way.

Presentations consist of five or more people and last no more than an hour and a half. Get together a group and we will come to you!

Participants learn:

Consumer Directed Personal Assistance Program (CDPAP) Update

While the NYS Department of Health is attempting to make changes to CDPAP as we know it, FLIC is

trying very hard to fight for the rights of seniors and people with disabilities to receive care in their home by aides of their choosing and maintain the CDPAP services that our consumers rely upon.

CDPAP is a Medicaid program that provides in-home services for more than 70,000 chronically ill and disabled individuals and employs more than 100,000 workers across New York. Fiscal intermediaries, like FLIC, provide a range of support services to the program's consumers and interface with the state Medicaid program. NYS is proposing drastic funding cuts to fiscal intermediaries.

FLIC has joined the Consumer Directed Personal Assistance Association of NYS (CDPAANYS), the New York State Association of Health Care Providers (HCP), and the New York Association on Independent Living (NYAIL), and 11 other fiscal intermediaries as plaintiffs in a lawsuit against the New York State Department of Health arguing that the proposed funding cuts will force many fiscal intermediaries to stop providing CDPAP services.

FLIC is committed to serving CDPAP consumers and will continue to provide updates as the litigation moves forward.

Exciting New Credential Opportunity for Direct Support Workers in the Disability Services Field



Tompkins Cortland Community College has developed a Micro-Credential in response to a request from Racker for people who provide direct service to individuals with disabilities, and is open to employees of other agencies or individuals as well. The Micro-Credential is designed to be a standalone credential used to further careers, or to be stacked along with existing degrees to show specialized knowledge in the field of disability studies. It only takes four classes to complete the credential, which will also earn college credits that can be applied toward a degree if desired.
